You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

## Tax Forms

**1. TAX RETURN FILERS—Important Note:** If the student or parent(s), filed or will file, an amended 2022 IRS tax return, file(d) separate IRS income tax returns, or had a change in the marital status after the end of the 2022 tax year on December 31, 2022, contact the Financial Aid Office before completing this section.

Instructions: Complete this section if the student or parent(s) filed or will file a 2022 IRS income tax return(s). As part of federal student aid eligibility, students, and spouses (as appropriate), will be required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data is ineffective. In other words, if the student and spouse filed separate 2022 IRS income tax returns, both must provide consent and approval to share and import income and tax information from the IRS. In most cases, no further documentation is needed to verify 2022 income information that was transferred into the student's FAFSA using income and tax information directly from the IRS.
